* Community Mediation Fee Schedule shall be applicable to relationship or neighbourhood issues arising between the parties. (If any commercial issue above the value of INR 5 lakhs is involved in the above dispute, it will be treated as a Commercial dispute).

Fee Payment Schedule

Registration Fee:

By the Party initiating mediation on filing of Dispute Submission Form.

Mediator Fee:


Once the mediator is appointed, the initiating party shall make a deposit for 2 sessions of mediator fee. If the mediation is abandoned due the absence of the opposite party or due to non-agreement in the first session itself, the balance amount will be refunded to the initiating party.

After the first session, both parties shall always keep a deposit of mediator fee of 2 sessions in advance. After the conclusion of the mediation, the amount will be settled.

The fee shall be payable in equal shares by the parties, provided that where one party fails to pay his share, the other party may pay that share, provided further that where the other party also does not pay the aforesaid share, the mediation proceedings may be suspended or terminated.

Rentals of Conference Rooms:

In case of mediations through Centre, the parties shall also pay rentals for the conference rooms and costs of coffee and snacks, as fixed by the centre.
