# PROFESSIONAL CERTIFICATE IN COMMERCIAL ARBITRATION

Alternative Dispute Resolution is no longer an alternative process. Arbitration is now one of the premier methods of resolving disputes, whether they arise in trade or commerce, business or family.

Commercial arbitration is essentially settling of disputes by referring them to a neutral person, an arbitrator, selected by the parties for a decision based on the evidence and arguments.

International arbitration is seen as a crucial tool for maintaining confidence in cross-border transactions and business. It is a rapidly growing area of law and is increasingly being adopted around the world by states and international businesses as a method for resolving international commercial and business disputes. The use and significance of arbitration are demonstrated by its increasing use by the business community.

The efficiency of arbitration is dependent on the expert knowledge and experience of the arbitrators. It is now manifestly clear that a comprehensive professional exposure to ADR is necessary to engage in cutting edge and high-quality law practice.

Globalization and interdependence, as well as profound international conflict, make the theory and practice of alternative methods to resolve disputes increasingly important. Demand for international arbitration lawyers is strong within both law firms and companies.

The Arbitration Training Program by the Indian Institute of Arbitration & Mediation (IIAM) is an APCAM Certified Training Program. It provides knowledge and an appreciation of commercial arbitration and its role within the Indian legal system. It offers the participants the theory of arbitration law and practice, with emphasis on procedure of arbitration, both ad-hoc and institutional, drafting of arbitration agreements, framing of issues and making of arbitral awards. The program will also look at the art of making dispute resolution clauses appropriate to the parties' business needs and dispute resolution desires.

The program provides a solid foundation for the participant to become an Arbitrator and expertise to represent in Commercial Arbitration as an Arbitration Lawyer / Consultant.

The Professional Certificate in Commercial Arbitration Program at IIAM, is conducted for 3 days offline or 4 days online.



## Accreditation:

On successful completion, the participant will be qualified as "IIAM Panel Arbitrator" and in accordance with IIAM Accreditation System ([www.arbitrationindia.com/pdf/iiam\\_qap.pdf](http://www.arbitrationindia.com/pdf/iiam_qap.pdf)), based on the Qualifying Assessment Programs (QAP) will be eligible to be accredited as "IIAM Certified Arbitrator" and can be empanelled with IIAM and Peacegate.

Being an APCAM Certified Training Program, completion of the program successfully will also enable the participant to apply for accreditation under the Accreditation norms of the Asia Pacific Centre for Arbitration & Mediation (APCAM), which would empanel the participant as an arbitrator in the roster of all the APCAM centres in 8 Asia-Pacific Countries. Once accredited, the arbitrator can upload their details in Peacegate and APCAM website, making them visible for users worldwide.

## Eligibility:

Lawyers, Chartered Accountants, Company Secretaries, Engineers, and all professionals or persons who have undergone graduate-level education are eligible for enrolment in this program.

## Evaluation & Certification:

The participant will undergo certain roleplays and will be given certain assignments during the course of the program. They are designed to help the participant to understand the practical aspects of arbitration and to write effective arbitral awards (both domestic and international). The participant's attendance and interaction during the program and roleplays will be assessed, along with the assignments. On successfully completing the program, the participant will be awarded the certificate, along with the course transcript.
