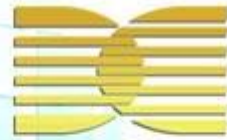

It makes access to justice easy and affordable, and at the same time design a new justice system that works at the speed of technology, enabling fast and fair resolutions anywhere within the reach of internet.

The UN Declaration on the Right to Peace noted that peace is not only the absence of conflict but also require a positive, dynamic participatory process where dialogue is encouraged and conflicts are solved in a spirit of mutual understanding and cooperation.

Peacegate helps not only people who have relationship disputes to choose the best option for resolving their disputes in the best manner possible, but also allow business community to handle their disputes in the age of digital economy.

Dispute Resolution in Digital Economy (DRDE) is possible only through online platform. UNCITRAL in its Technical Notes on ODR has emphasised equal treatment of the parties, maintaining neutrality of the system, providing consistent, fair, transparent process with accountability, due process and predictability. It has also highlighted the desirability to disclose relationship between the ODR Administrator and a particular vendor, so that users of the service are informed of potential conflicts of interest. Thus Peacegate dispute resolution application is best suited for all e-commerce platforms to address their dispute resolution requirements.

Even though the default language is English, the App has incorporated the facility for multilingual options, so that the users will not have any language barriers.

Now you can register your disputes, negotiate with the other side, invoke mediation or arbitration and resolve your disputes sitting at the convenience of your home or office. 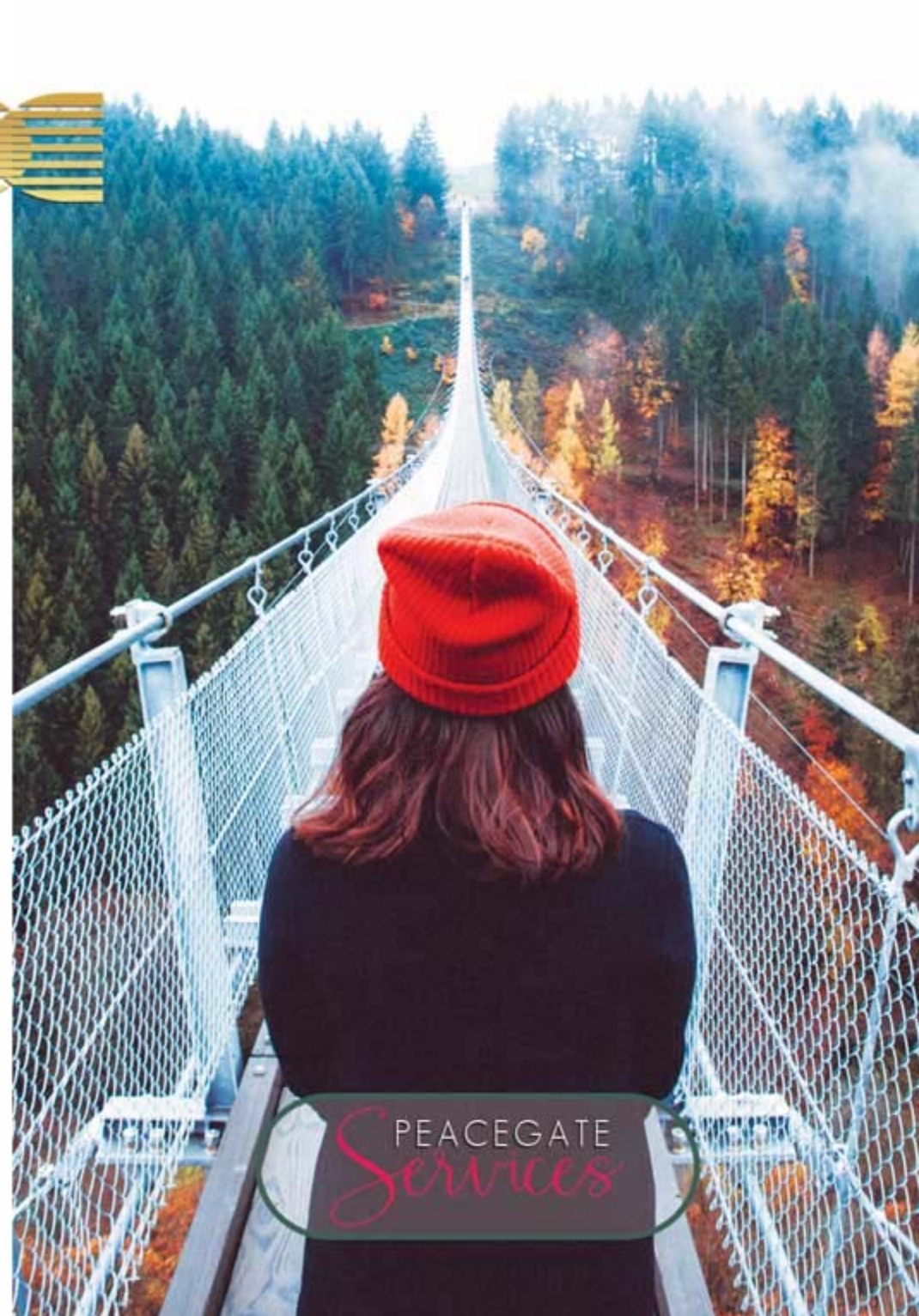

The administrative process of appointing the mediator and procedural requirements will be done with Peacegate automation process, ensuring a hassle free conduct of mediation. Peacegate also allows to commence arbitration process, if there is appropriate arbitration clause in the contract.

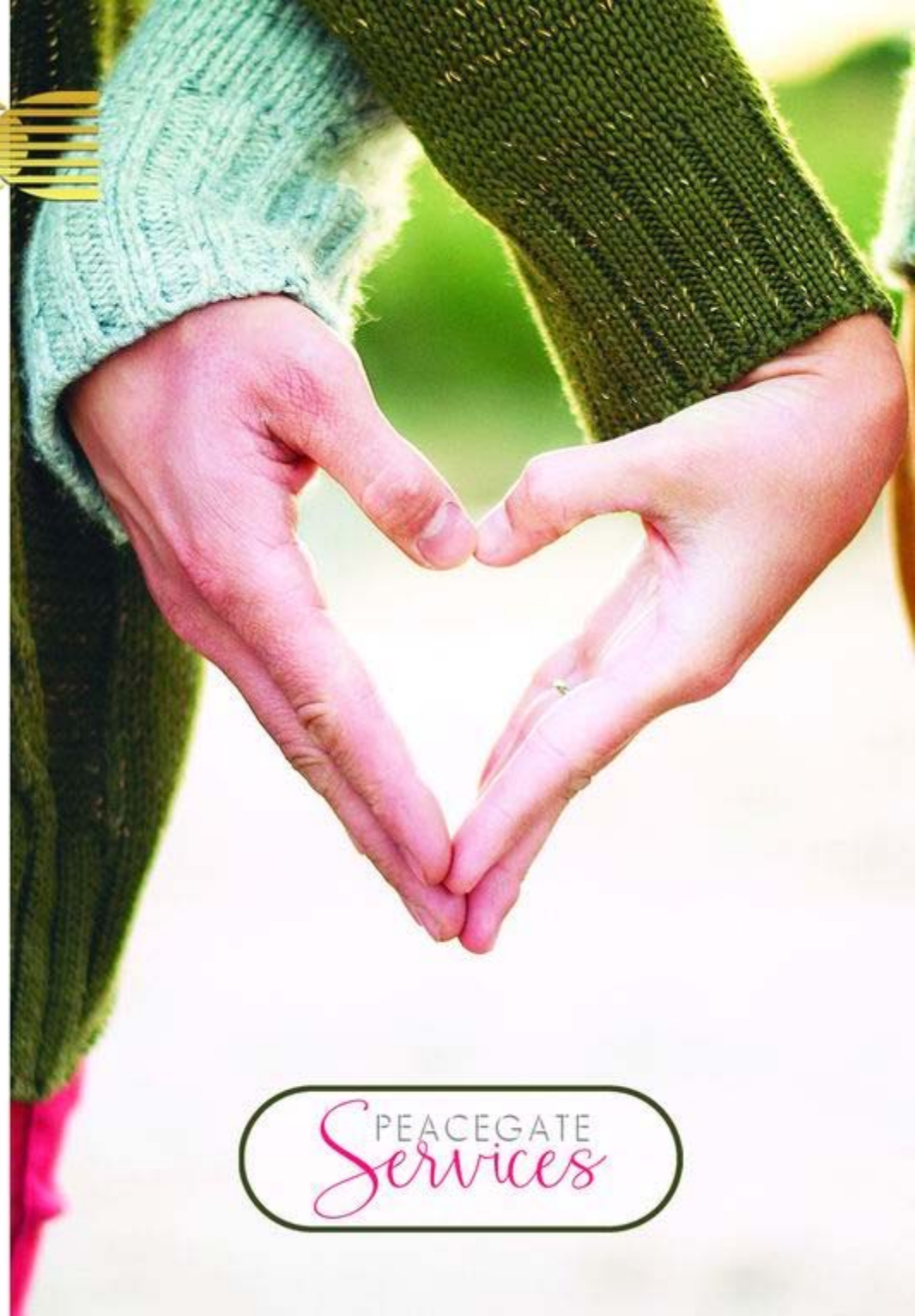

IIAM Academy

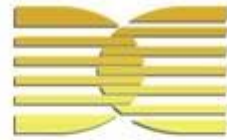

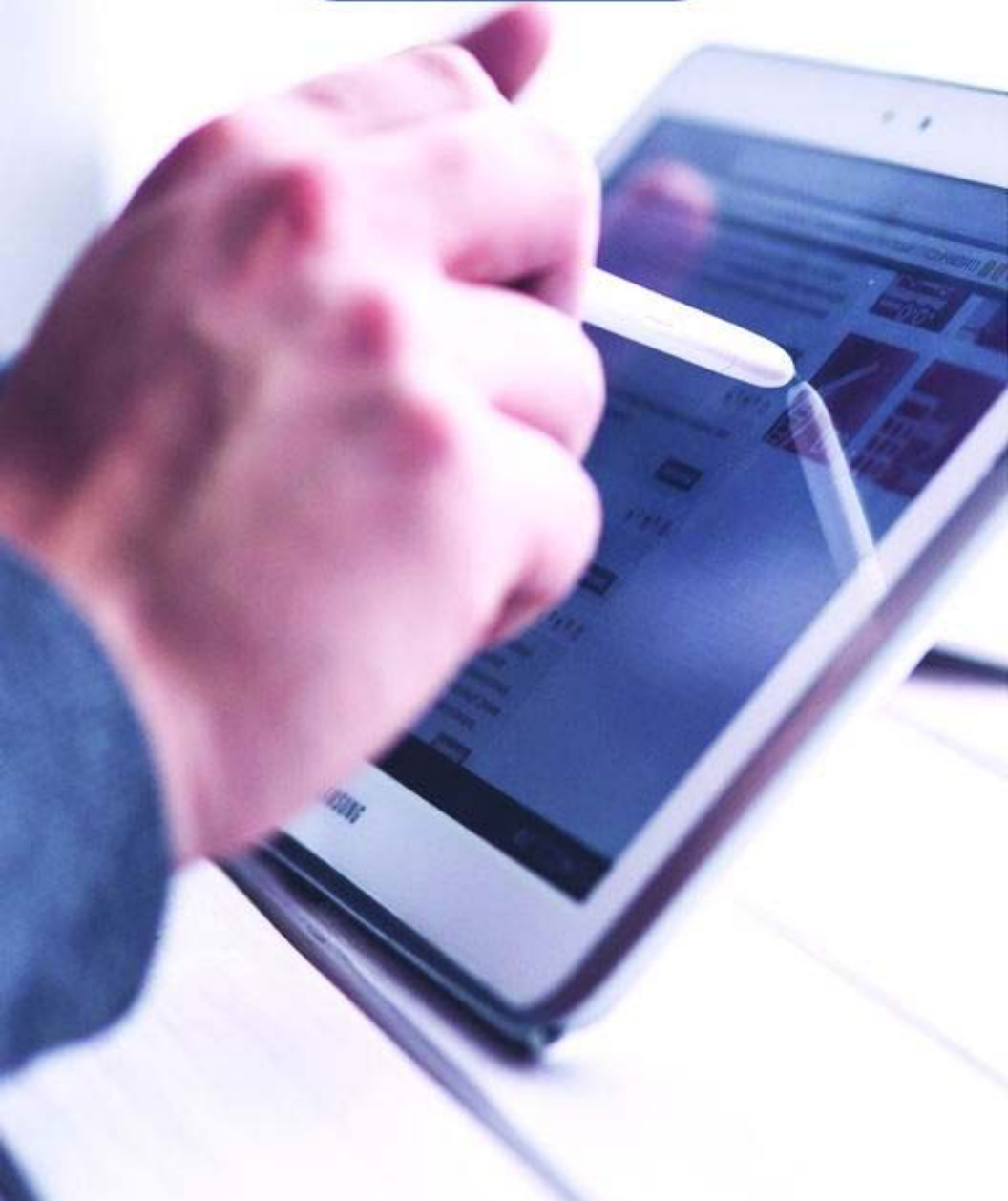

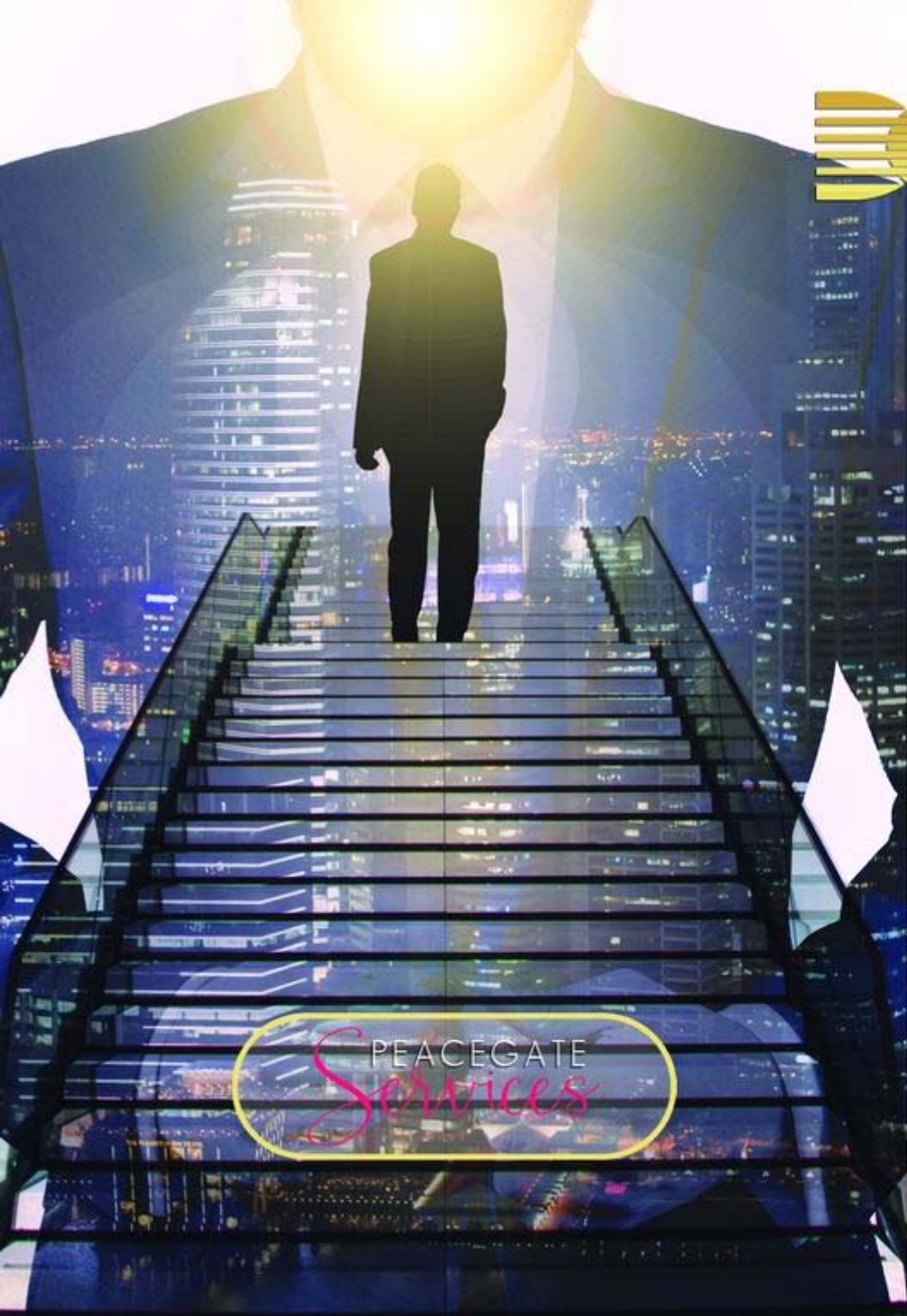
Edra Meet Online Platform
